The Cancer Legal Resource Center (CLRC) is a national, joint program of the Disability Rights Legal Center and Loyola Law School Los Angeles.

The CLRC provides free information and resources on cancer-related legal issues to cancer patients, survivors, caregivers, health care professionals, employers, and others coping with cancer.

The CLRC helps people with a variety of legal issues, including:

- ◆ employment and taking time off work;
- ◆ access to health care;
- ◆ getting and keeping health insurance after a diagnosis;
- ◆ disability insurance and government benefits;
- ◆ insurance navigation;
- ◆ managing the cost of cancer care;
- ◆ estate planning, advance directives, life insurance; and
- ◆ understanding health care reform.

How does the CLRC help those coping with cancer?

A cancer diagnosis can bring with it a variety of cancer-related legal issues. These legal issues may cause people unnecessary worry, confusion and stress, and can be overwhelming.

When these legal issues are not addressed, people may find themselves surviving treatment, only to find that they have lost their jobs, homes, or insurance.

The two main avenues for receiving assistance from the CLRC are through the national Telephone Assistance Line and our national education and outreach efforts.

Telephone Assistance Line

The CLRC's national, toll-free Telephone Assistance Line (866-THE-CLRC) provides callers with free and confidential information about relevant laws and resources for their particular situation.

Education & Outreach

The CLRC conducts national education and outreach efforts to educate people about their cancer-related legal rights and options. CLRC staff travel around the country to provide educational seminars, host Cancer Rights Conferences, and attend outreach events in the cancer community.

How the CLRC is Funded

The CLRC is a national, joint program of the Disability Rights Legal Center and Loyola Law School Los Angeles. Komen for the Cure®.

Future CLRC Funding Goals

The CLRC is working to obtain additional funding to fulfill the future goals of expanding programs and services to under-resourced communities. With additional grants and donations, the CLRC hopes to:

- ◆ Increase the availability of CLRC services and resources in multiple languages, including the translation of *The Manual: A Legal Resource Guide for People with Cancer*
- ◆ Expand the annual Cancer Rights Conferences to multiple national dates and locations to provide regional audiences with free access to needed legal information and resources
- ◆ Increase services to rural communities
- ◆ Increase the availability of online materials and seminars
- ◆ Increase the number of attorneys based in local offices throughout the United States

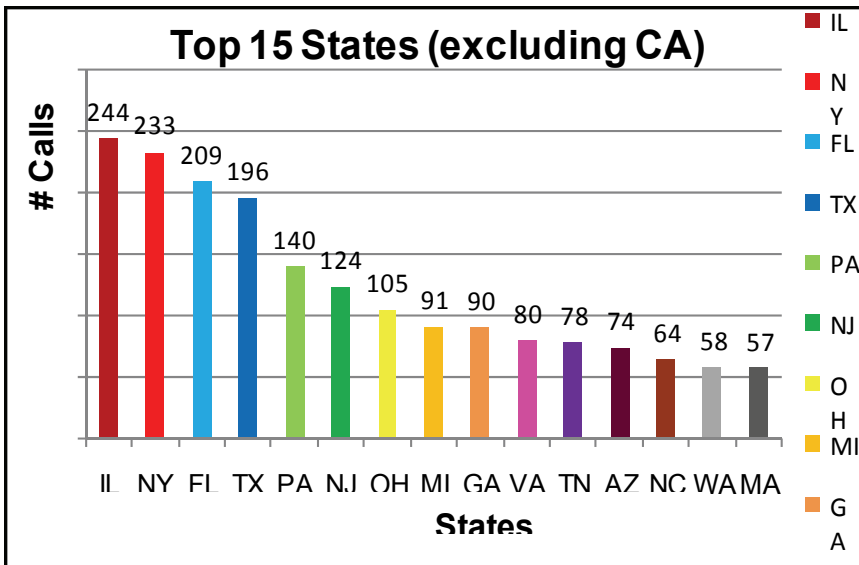

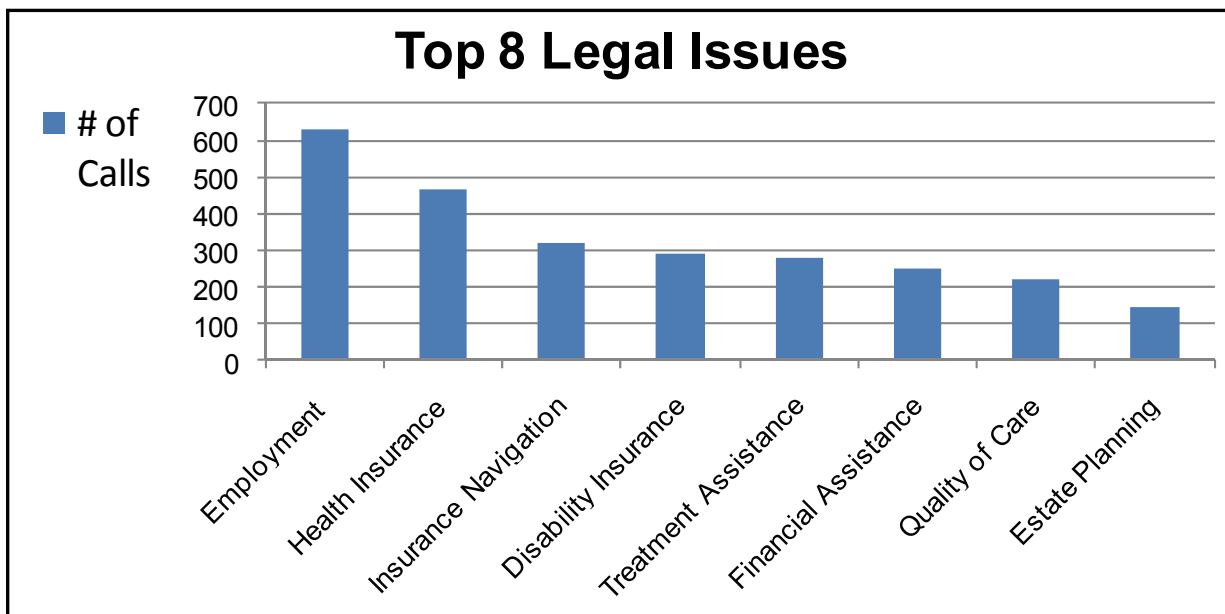
2010 Telephone Assistance Line Statistics

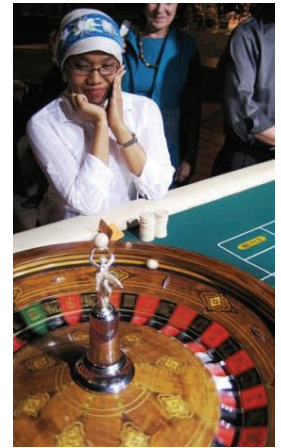
Between April and December 2010, *The HCP Manual: A Legal Resource Guide for Oncology Health Care Professionals* was viewed on our website over **8,600** times.

Getting Health Care Providers Involved

In 2009, the CLRC received a **LIVESTRONG** Community Program Grant to focus on educating health care professionals across the country on cancer-related legal issues. Our goal is to educate frontline oncology health care providers (e.g. doctors, nurses, social workers, psychosocial care providers, and patient navigators) to identify the presence of cancer-related legal issues for their patients and refer them to the CLRC or other services as appropriate.

The CLRC works to educate health care professionals about cancer-related legal issues in a number of ways. During the Cancer Rights Conferences, presenters focus on identifying scenarios that present cancer-related legal issues and relevant protections. What may seem

like a hardship for a patient may really be a legal issue that can be addressed.

In addition, the CLRC developed *The HCP Manual: A Legal Resource Guide for Oncology Health Care Professionals*, which is available online, free of charge. This manual is a resource for health care professionals covering the various issues often relayed by patients coping with cancer, and provides valuable information about navigating cancer-related legal issues, from diagnosis through survivorship.

The CLRC also created a survey of health care professionals to uncover the demographics of patients, the frequently asked cancer-related legal questions and concerns raised by patients, and thoughts on the role health care professionals play in providing cancer-related legal

information to their patients. The survey results will help the CLRC improve services to the cancer community.

In addition to the survey, the CLRC conducts focus groups with health care professionals to help identify what types of information, resources, and training are most beneficial for them, their patients, and their colleagues. Attendees provide feedback and brainstorm with the CLRC on ways to reach other professionals in the cancer community, while gaining hands-on tools to identify cancer-related legal issues that affect many of their patients.

Professional Panel

The CLRC provides critical information and resources that help callers understand their rights and options; the CLRC does not offer direct legal representation. Sometimes, CLRC's callers require legal advice, representation, or direct advocacy in order to resolve their legal concerns. The CLRC refers these callers to attorneys or other professionals on the CLRC's Professional Panel who practice in their geographic area and have expertise in the area of their inquiry.

The Professional Panel Changes Lives for Cancer Patients

L, a teacher, called the CLRC after she felt intimidated and harassed by her supervisor. She was diagnosed with breast cancer and was slated to begin treatment; however, she was concerned that if she took a medical leave of absence she would lose seniority and ultimately be transferred to a school further from her home. L tried discussing her concerns with her employer but found the employer to be hostile and uncooperative. The CLRC was able to refer her to a member of our Professional Panel who was able to help L negotiate with her employer, and allowed her to focus on her recovery, rather than worrying about keeping her job, and ultimately gave her the confidence to return to her true passion, teaching children.

M called the CLRC from New Jersey. Her first diagnosis of breast cancer was several years ago. She was treated and had silicone breast implants. She then had a recurrence of breast cancer and was scheduled for surgery again. She needed both a breast cancer surgeon and a plastic surgeon. She needed a particular plastic surgeon who was familiar with silicone breast implants. However, he was not approved by her health plan. M's surgery was rapidly approaching and her insurance carrier was not responding to her appeal. The same day M called, the CLRC contacted one of our Professional Panel members in New York. The attorney contacted the insurance carrier on M's behalf, and two days before her scheduled surgery, the carrier reversed its position and approved coverage for the surgeon who had the necessary expertise for a successful surgical outcome.

What can the CLRC do for you?

If you have a diagnosis of cancer, the CLRC may be able to:

- ◆ Help you determine what you may or may not need to tell your employer about your cancer diagnosis.
- ◆ Walk you through the process to request a reasonable accommodation at work or time off for treatment.
- ◆ Provide you with information about your health insurance options including government benefits.
- ◆ Give you information about your rights to appeal an insurance company's decision not to pay for your treatment.
- ◆ Provide you with knowledge about estate planning and life and disability insurance options.
- ◆ Educate your caregivers about rights and protections they may have.
- ◆ Help you understand how the Patient Protection and Affordable Care Act (health care reform) applies to you and your family.
- ◆ Give you tips on how to avoid, deal with, and pay for your medical bills.
- ◆ Inform you about your legal protections if you have a genetic predisposition to cancer.
- ◆ Teach you about how to be an effective advocate within the legislative process.
- ◆ Connect you with a lawyer in your area who may be able to further assist you.
